

**Bharatpur Water Supply Management Board (BWSMB)**  
**Bharatpur, Chitwan**  
**Invitation for Sealed Bid**

1. BWSMB invites sealed bid from registered Suppliers for the supply and delivery of vehicle.
2. Interested eligible Suppliers may obtain further information and inspect the bid document forms at the above office.
3. Bid documents may be purchased by eligible Suppliers on the submission of a written application with a cash payment as mentioned for bid (non-refundable) from BWSMB until 30 th day of first publication date of this notice during office hours. The bidders are required to submit attested copy of citizenship, firm registration certificate (renewed up to 072/73), VAT Registration and Tax Clearance Certificate of Fiscal Year 2071/ 072.
4. The submission of bids is acceptable within 31st day up to 12.00 hours of first publication date of this notice and must be accompanied by a bid security for the supply. Bids received after this deadline shall not be accepted.
5. Bids must be valid for a period of **90 days** after opening of Sealed bidding document and must be accompanied by Cash Security or Bank Guarantee, amounting to as below which shall be **valid for 120 days** after opening of the bid opening date.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Account No. **00300067CA of the above office** at Prime Commercial Bank, Bharatpur, Chitwan and submit the receipt of the deposited amount of cash along with the bid documents.
7. Bid should be submitted in the name of BWSMB for which the bidding documents have been purchased.
8. Bidder should submit the bidding documents in a sealed envelope on which name, address of bidder and bid package shall be written clearly.
9. The provisions in the instruction to bidders, the general and special conditions of contract are provisions of standard bidding documents.
10. Bids will be opened in the presence of Suppliers' representatives who choose to attend at **14:00 Hrs on 31<sup>st</sup> day of first publication of this notice at** the above office.
11. If the last date of purchasing, submission and opening of bids falls on a government holiday then the next working day shall be considered the last day.
12. The bidder must submit the following documents along with the bid otherwise bid will not be entertained
  - (a) Manufacturer's authorization letter in the name of purchaser of the vehicles to be supplied.
  - (b) Manufacturer's quality control certificate including ISO/ISI/NS certificates.
  - (c) Manufacturer's detailed product catalogue of to be supplied item.
  - (d) Authorized service centre certificate.
13. Unofficial, unsealed, unsigned, lately delivered and improper bids will not be entertained.
14. Bid must be prepared neatly and clearly. The bidding rate must be quoted both in figures and words in bill of quantity sheet provided in bidding document. If the rate in figures and words vary or not clear, the rate mentioned in the words will be considered as actual bid rate.
15. If licensed proprietor or firm or company or any individual becomes unable to appear for the purchase of bidding documents . His/her authorized representatives may purchase the bidding documents upon submission of letter of authorization and related documents.
16. Conditional bids will not be entertained.
17. Other terms and conditions not mentioned above will follow as per prevailing rules of government of Nepal.
18. The BWSMB reserves the right to accept or reject, wholly or partly any or all the without assigning any reason, whatsoever.
